- g) To train and make all personnel aware of Quality, Environment and Food Safety in accordance with the needs and situations existing at any given time and to ensure the skills related to these systems.
- h) Evaluate and know all the environmental impacts and the footprint associated with our activities and the products we develop.
- i) Comply with current legislation and regulations and, as far as possible, exceed the requirements established therein provided that this is associated with a benefit for the company, its environment and / or customers.
- j) Make a sustainable use of natural resources, raw materials and energy.
- k) Manage and treat our waste in the most respectful way with the environment and minimize the management of them in all our operations.
- I) Continually apply, review and evaluate our HACCP in order to ensure the safety of our products.
- m) Guarantee food safety as members of the chain that we are, committing ourselves to continuously improve our FSMS.
- n) To develop an annual quantification of the greenhouse gas (GHG) emissions generated by our organization.
